# The Journey Forward Requires Listening to feedback

The 2022 conference theme of "jOURney Forward" has been a goal for the association as well. These past years of navigating through a pandemic have forced us to recognize a need for change and flexibility. At the time of writing this article, the country is experiencing another winter in crisis with the flu, COVID-19, and RSV circulating. Many of us remain uncomfortable in large crowds and may still be working and traveling in spaces that require masking and other safety precautions. The health and safety of everyone involved in the conference was and will continue to be a high priority for the association, including the selection of conference sites that have adequate space for conference attendees and vendors.

#### **Event Planning**

Planning a conference event begins several years in advance, including signing binding contracts to secure the venue. When selecting the venue, key factors of the decision-making process include availability, the accommodations offered, price, and location. The TOTA annual conference hosts one of the largest exhibit halls among state OT associations and finding venues with halls large enough to accommodate the number and variety of exhibitors is challenging.

#### **Site Selection**

In 2018, the Embassy Suites and Convention Center contract was secured for the 2020 annual conference. Because of the COVID-19 pandemic, all in-person events were canceled. To avoid significant financial loss for TOTA, the 2022 conference was scheduled for the Embassy Suites location in Denton. The 2021 annual conference was contracted at the Houston Marriott Sugar Land until COVID-19 required TOTA to find a larger venue with adequate space for social distancing. There were very few facilities available at short notice that were able to accommodate our space requirements. But with the help of Angela Feinstein, a meeting procurement and site selection expert, we were able to secure the Hyatt Regency Downtown Houston.

During this period, the travel and hospitality industry sustained a devastating financial hit which resulted

in a reduction in our negotiating power. As a result, it was more fiscally responsible for TOTA, like many other organizations trying to find event venues, to sign a two-year contract with the location rather than the typical one-year contract. For this reason, we are returning to the Hyatt Regency Downtown Houston for our 2023 conference but since under contract, it will still be at the lower 2021 rates.

The planning for the 2024 conference has already begun and at the time of the writing of this article, we have submitted more than eleven requests to event venues and have yet to be successful in securing a location. The search included regions around McAllen, San Antonio, Austin, and Dallas. Because so many organizations were required to sign multi-year contracts to host their event with the same venue in 2020 & 2021 that availability for 2024 is extremely limited and even our first choice of venue could only offer us November 22-23. I promise to keep you updated.

#### Program

We reviewed your feedback from the conference and the committee is considering the requests for more short courses, a student-focused track, and the ability to identify if the presenter is a student or a practitioner. We have also had conversations with our members who work in academia and student members regarding the poster sessions which have been virtual for the most recent conferences. We plan to offer the option for inperson poster presentations again for those wanting that experience, but with smaller poster sizes.

#### **Price**

Conferences are expensive and it is not just the rental of the space and technology that must be considered. TOTA also takes the cost of the hotel rooms, event food and beverage minimums, and technology fees for a venue into consideration during the process. Most conference attendees do not realize that all conference venues require minimum food and beverage spending amounts ranging from \$26,000 to \$50,000 for the event. The price of coffee and water for hot tea can range from \$65 to \$100 per gallon. TOTA's conference has a tradition of

Fortunately, some of these costs are covered by our many wonderful vendors who agree to sponsor the cost of coffee, conference bags, refreshments, lanyards, and even part of the boxed lunches. So, the next time you are in the exhibition hall, be sure to thank them for their generosity.

What you will see in 2023 is a "cost-based" conference fee. Cost-based pricing means we will review the overall cost of producing or hosting the conference, which includes marketing, printing, food & beverage, technology needs, professional fees, exhibit hall set/up, and many other necessary expenses to host a conference. Essentially there will be a price for members and a higher price for nonmembers. Students and practitioners will pay the same price. Discounts will be available for volunteers, board members, committee members, and presenters, including our students. Early bird registration will remain in place.

#### **Business Meeting**

We are considering hosting the TOTA Annual Business Meeting virtually before the conference to make more spots available for educational courses. # 2023 Conference Wrap Up

What a TOTA conference we had last month in Denton! Did anyone else experience a jolt of excitement during those two days? Whether attending informative sessions, hanging out with your conference buddies (you know, the people you only see at conferences but who feel like old friends), or physically meeting your Zoom colleagues, this conference felt special.

The conference theme, "jOURney forward", encouraged movement from the holding pattern we found ourselves in during the past two years. It feels like we are starting anew — not returning to how we once were but navigating new terrains.

Nowhere was this idea more apparent than during the OTA Forum. The three topics addressed during the Forum — OTA Empowerment, pursuing Specialty Certifications, and Mentoring — struck a chord with those in attendance and resulted in heartfelt conversation.

Some participants expressed the desire for increased mentoring — both clinically and for professional growth, some participants expressed concerns regarding how legislation may affect future employment and others expressed frustration that they are seen as "just a COTA." The challenges of being a COTA are apparent for some, but all expressed pride, joy, and love of the job.

OTA entrepreneurship drew some of the biggest conversations. Many in attendance expressed the desire to start a private business, but not knowing how to start, which OT services to provide or if they could even provide said services as an OTA were some of the obstacles mentioned.

The OTA Forum is a platform to share knowledge, voice concerns, and collaborate on the "jOURney forward" for OTAs. Using these discussions as a starting point, the goals for 2023 are to find traditional and innovative ways to address these ideas. Another goal is to establish an active OTA community across the state. Finally, and perhaps most importantly, is increasing OTA membership from the approximately 150 members currently registered. Imagine if each of us were to recruit one OT practitioner to become a member. To quote Dr. Seuss, "Oh, the places [we'll] go."

Each one, Reach one. Sounds like a future call to action.






le had an amazing opportunity to collaborate with OTA practitioners and students at the OTA Forum at TOTA's conference in Denton.

At conference we presented on the value of Micro Credentialing particularly for OTAs. AOTA supports the benefits of Micro Credentialing for OTAs because it allows practitioners the ability to share learning

achievements with peers and potential employers, help achieve professional development goals and improve client outcomes. We looked at micro credentialing options from AOTA including "Home Modifications and Fall Prevention Micro-Credential Course Bundle." Under this bundle the practitioner would complete a series of courses and upon completion receive a professional certificate. (See model below from AOTA.org)



We also discussed other available credentials outside of AOTA, available for OTAs, including Certified Aging in Place Specialists (CAPS) and Certified Brain Injury Specialist (CBIS).

The response of the group was positive and wellreceived. Participants described micro-credentialing as a positive alternative for those not interested in returning to a college/university for a post-graduate degree and a way to further their skills in a desired specialty area. At the end of the Forum, the committee and participants

had the opportunity to network and brainstorm for future OTA forums.

We welcome OTAs who are interested in increasing their involvement with the association. OTAs are eligible to serve either as a committee member/chair or executive role including the President! Please join us as our voice is truly valued with TOTA, but there are only a handful of us speaking for all of us. # Day at the Capitol: More than professional "responsibility," it's your profession's "response-ability" (Minkler, 1999).

The date is Tuesday, May 29th, 2023, the day after Texas'88th Legislature's regular session ends. As you pour your first cup of coffee, you wonder what laws have passed that will impact the job you are getting dressed to go to, the clients you serve, and your profession. No one knows the answer to this question since we are still in January 2023. However, as you pour that first cup of coffee on May 29th, 2023, you can know that your voice was heard, and you advocated for your patients, profession, and future.

Advocacy is a simple concept; we speak up or work on behalf of other individuals, groups, or causes (Jacobs and McCormack, 2019). Advocacy aligns with our profession's core values, such as equality and justice (AOTA, 2020). This spring, there are many opportunities to transform our values into action including Day at the Capitol. Day at the Capitol is a TOTA-sponsored event where practitioners and students from across Texas travel to Austin to meet with their elected officials and advocate for their profession. Participants are organized into small groups and receive specific talking points, pre-event orientation, and additional resources to ensure a successful meeting. If this is your first meeting with an elected official, TOTA will pair you with someone to facilitate your discussion and help you advocate for our profession.

Your participation in Day at the Capitol plays a pivotal role in TOTA's success in this legislative session. While everyone's voice carries an important message to their single elected official, this message becomes amplified when delivered by a group of practitioners and students delivering the same message, to numerous legislators, on the same day. We need to leave a lasting impression upon Texas legislators that OT is *the* solution in this legislative session.

During this upcoming session, TOTA plans to focus our advocacy efforts on Mental Health. Across the state in the past year, a spotlight has been cast on how the

State can best support Texans' mental and behavioral health. Whether this is through creating new programs, new facilities, or increasing funding and/or utilization of existing State programs, as a profession we want to be: (1) recognized in legislation that supports mental and behavioral health, (2) included in an interdisciplinary approach to meet the needs of Texans, and (3) reimbursed at a rate that reflects the tangible outcomes attributed to OT. Registration for Day at the Capitol is easy. Follow the link here <a href="https://www.tota.org/day-at-the-capitol">https://www.tota.org/day-at-the-capitol</a>. Make sure to register individually, even if you are attending as a group. Individual registration allows us to identify your specific legislator to schedule your meeting. Your advocacy efforts over the next 140 days can help support policy impacting your practice for years to come. Advocacy is a part of a process, and it is impossible to know the outcome of our collective efforts. However, on May 29th, as we take the first sip of coffee, I want you to raise your mug, knowing that your continued advocacy helped shape policy and practice this year for the clients we serve, the profession we love, and our future. See you in Austin.

Work with TOTA Board of Director's strategic goal to enhance interactions with the membership through virtual events, corporate relationships, and social media as evidenced by 5% increase in overall licensee membership.

Jason Perez OTD Class of 2023 UT Health San Antonio This project will address airline travel equity for wheeled mobility users by utilizing an adapted multi-tiered system of support intervention approach that focuses on education and influencing the culture around air travel.

Much of the responsibility to protect wheelchairs and scooters while traveling via aircraft is placed on the end user. While educating the end user is undeniably an important factor, educating airlines, airports, and practitioners, as well as advocating for more unified standards would create a sense of accountability that the air travel industry is currently lacking. Educating baggage handlers on what is at stake for this population when their mobility equipment is mishandled, coupled with a plan to disburse to practitioners on how to best advocate for their clients, will bring awareness to the lack of protective regulations in the industry. The percentage of wheelchairs and scooters that are being mishandled is remaining constant, even as the overall number of wheelchairs and scooters that are being enplaned is increasing as more people begin to travel since restrictions put in place during the Covid 19 pandemic are being lifted. With supply chain issues causing difficulties across industries and a lack of awareness of the stakes for the end users in the air travel industry, wheelchair users simply do not feel comfortable risking traveling via airlines creating inequitable access to air travel.

This project will educate stakeholders in the airline industry, creating awareness and starting conversations about how to address the current barriers identified by end users. Using an approach that will facilitate education and advocacy at multiple levels of stakeholders will create a holistic understanding of issues and how to best address them moving forward. Understanding how barriers are formed and perceived by all stakeholders allows for a more meaningful conversation about how to adapt or modify these barriers to promote equitable access and participation in air travel.

#### **Greetings!**

#### We Are All OT Practitioners!

How do you introduce yourself to patients, family, and friends? Are you an OT Practitioner? Do you say I work in the field of OT? You may not sit and think about how you have introduced yourself to others. In school, a lot of information is learned but not a lot of emphasis is always placed on titles. Students are taught about the field of occupational therapy and told to make sure to introduce who they are and that they are with "occupational therapy" to clients and/or patients. But the translation of our titles sometimes becomes miss construed. As we are still the unknown and not always understood profession.

I have heard individuals outside of the OT profession say they do not understand why we are not just OTs and OTAs. And then an explanation must ensue. We all know as graduates from OT and OTA programs and upon passing their board exams we are given a credential from the National Board for Certification in Occupational Therapy (NBCOT). This is where the confusion begins. Occupational



















therapist have been provided the "R" credential providing them with the title "OTR" and Occupational therapy assistants with the "C" credential upon passing the board exam. However, this is not a credential needed to practice (at least in the state of Texas). There are OT practitioners who do not renew their NBCOT credentials. This is another reason it is important to spread the message to all to utilize saying, I am an OT practitioner or specifically an OT or OTA. As I recently read an OT practitioner write on a social media post, why would we want to walk around calling OTs "otters" and OTAs "kotas". We are just confusing society and each other. Never assume an individual has kept their credentials from NBCOT. Proudly keep your respective credential but make attempts to refrain from saying "OTR" or COTA" when acknowledging yourself or other colleagues. There is a domino effect when utilizing those terms as prospective students are asking to be admitted to "OTR" and "COTA" programs. Education and modeling the correct terminology is key!

As we continue to move the profession forward, let us first remember to acknowledge ourselves as OT Practitioners! We have to be an example to ourselves for others to understand and recognize the genuine capacity of the occupational therapy profession. That begins with us utilizing the correct titles as OT Practitioners.


### It's a new day for mental health!

n October 8th, occupational therapy practitioners, students, and their families came out to support the TOTA Rio Grande District at the National Alliance on Mental Illness (NAMI) Awareness Walk. The Rio Grande District raised \$1,295 for NAMI El Paso. Our walkers and volunteers also took the opportunity to advocate for our profession and educate our community on the role OT has in mental health.

Occupational therapists do not need to be mental health specialists to promote mental health. Mental illnesses are often associated with functional impairments and can be found among any population. Depression and anxiety disorders have been linked to diagnoses such as stroke, Parkinson's disease, and spinal cord injury to name a few. General practitioners can play a role in supporting the mental health of their patients and NAMI offers resources to help practitioners working with any individual at risk for mental illness.

The NAMI website offers tips on identifying warning signs that someone might be suffering from a mental illness. Signs to look for include:

- · Intensifying worries or fears
- Feelings of hopelessness
- Feeling moody or sad for more than 2 weeks
- Changes in eating or sleeping patterns
- Withdrawing from others
- Decreased desire to participate in daily life activities



- "I noticed you have been eating less (sleeping more, etc.). Is everything ok?"
- "I've heard your family say you haven't been acting like yourself lately. Is something going on?"
- "I sense you are going through something and I want you to know you are not alone. The team and I are here to help."

Use active listening when discussing mental health issues with a patient and validate feelings before offering solutions. Remember that people don't care how much we know until they know how much we care. From there we can address any mental health issues through education on coping strategies and promotion re-engagement in meaningful occupations. We can also make recommendations for further treatment, such as an evaluation from a psychologist.

Other helpful tips include:

- Check back in with the individual to see how they are doing.
- Learn more about the mental health condition and share that information with the individual.
- Avoid using dismissive language, like "It's not all that bad", or "You'll get over it."

And finally, don't forget that your mental health is important too! Take time for yourself to step away from the responsibilities of caring for others.

The American Occupational Therapy Foundation (AOTF) is the only national nonprofit organization investing exclusively in new occupational therapy (OT) research and the future OT workforce. Quality, data-driven evidence is essential to delivering quality care to your clients, securing reimbursements, and strengthening the value of your profession. The AOTF mission, "to advance the science of occupational therapy", is working for you by building evidence in demand, supporting OT students with scholarships, and providing the profession with informative, CEU-eligible programming that elevates occupational therapy as an evidence-based health care practice.

## How can TOTA members benefit from AOTF and why support AOTF?

First, AOTF has resources for OTs throughout their careers. From scholarships for OT, OTD, OTA, and PhD students, to CEU-eligible programs (both in-person and virtual) to our peer-reviewed journal, OTRJ, and free monthly newsletter, AOTF is providing the OT community with valuable information, financial assistance, and research resources. Did you know that TOTA has a scholarship with AOTF that supports 2 OT students in Texas each year? In addition, AOTF offers over 50 scholarships to OT students based on merit, need, career interest, volunteer leadership, and diversity representation.

Second, AOTF's research mission is addressing two critical needs for OT: the need for more evidence and the need for more OT researchers. We know that having the best, most recent, and more relevant OT evidence can improve their delivery of care as well as address issues that plague healthcare systems and health service environments. More OT evidence from AOTF funded studies can help TOTA advocate for current priorities, telehealth, mental health and school-based practitioner activities. Above all, it helps demonstrate that OT interventions meet the criteria for evidence-based practice.

AOTF is supporting OT researchers with three robust

research grant programs that fill a critical gap in OT research; funding for early-stage studies. No other organization is helping OTs with new and novel ideas collect pilot data and build proof of concept like AOTF. What also makes our grants special is that each researcher receives mentorship from senior-level investigators.

#### What areas of care is AOTF funding?

Aging in Place, Autism, Bullying, Cancer Survivorship, Chronic Conditions and Pain, Diabetes, Early Intervention, Fall Risks, Family Issues and Caregiver Needs, Functional Cognition, Health Behaviors, Medication Management, Mental Health and Serious Mental Illness, Motor Learning, Parkinson Disease, Sleep, Spinal Cord Injury, Stroke, Traumatic Brain Injury, Trauma, Telehealth, Upper-Extremity Rehab.

Furthermore, AOTF is investing in researcher training programs to build the future leaders we need in OT departments across the country.

TOTA members should support AOTF so we can continue to generate scientific evidence to support OT practices. The grants, scholarships and programs offered by AOTF each year are made possible solely through the generosity of philanthropic gifts. It is only with the support of our OT community that AOTF can continue to build the evidence OTs need and address the challenges central to our profession.

TOTA members can also support their alma mater in the annual, student-led fundraising competition, St. Catherine Challenge. This year Texas Tech Health Science Center, Texas Woman's University, and 55 other schools are helping raise money for new OT research through this friendly competition. Winners will be announced at the AOTA Conference in April 2023.
